## A Memorial Resolution Andries C. "Harry" Bakker

Whereas, God, our loving Heavenly Father, has, in his perfect wisdom and love, called Andries "Harry" Bakker, our beloved brother in Christ, faithful church member, elder emeritus, and dear friend to his eternal rest and heavenly home on January 24, 2012; and

Whereas, Harry was born in the Netherlands on June 6, 1914, and during World War II was sent by his government to Jackson, Mississippi, with "The Dutch Fliers." In Jackson, Harry met Gena Kate Brister and they were married on March 25, 1943. After the war, they lived two years in the Netherlands, then returned to Jackson where Harry worked as a machinist. They began attending Westminster Presbyterian, a new church plant in West Jackson; and

Whereas, Harry made profession of faith and was baptized at Westminster on December 18, 1949 and served the church faithfully for sixty-two years; and

Whereas, Harry was selected by the congregation on February 22, 1953 to serve as a deacon and subsequently selected on February 7, 1954 to serve as a member of its Session and served faithfully until his retirement on November 11, 1984; and

Whereas, Harry was a godly husband, humble father and beloved grandfather to his dear family. He was married to his wife Gena Kate for sixty years, until she was called to her heavenly home on September 12, 2003; and

Whereas, Harry Bakker is remembered for his winsome, humble and gracious demeanor, his wise counsel, his concern for the church musician to be included in staff pay raises, and his regular church attendance, sometimes bringing a neighbor with him, all setting a worthy example of a faithful follower of Christ.

Be it therefore resolved by the Session of Providence Presbyterian Church, Clinton, Mississippi
